HOW TO SUBMIT MY VIDEO FOR WRO 2020-X

1. Download the Consent and Media Release Form (see next page)
 - a. Complete **one form per team member**
 - b. Take a picture or scan all the documents
2. Make sure your video meets the requirements. Refer to “How to Create my Video for 2020-X”
3. Post your video online on a **public** social media account (Facebook, Instagram, YouTube or Tencent Video).

If your account or your post is private, we won't be able to see your video and you won't be judged. If you are underage, the coach/parent can publish the video.

4. Click on Submit Video to open the form
5. Enter the required info
6. Copy/paste the link to your video
7. Upload the consent forms
8. Click on Submit

3. Participant's Consent

The Participant identified above desire to participate as a team member, coach, judge or in some other manner in the Events. As a condition for participation, the Participant agrees, confirms and undertakes with the Organizers as follows:

- 3.1 The Participant in the Events agrees that while the Organizers shall endeavour to provide a reasonably safe environment in which the Events are carried out, there may nevertheless be risks associated with the Events. Accordingly, the Participant agrees that his or her participation shall be done entirely at its own risk and the Participant shall be deemed to have understood the risks and conditions associated with the Events. The Participant further agree not to hold liable, the Organizers, their respective subsidiaries, employees and agents, to the extent permitted by law, for any death, personal injury, loss or damage arising out of the Participant's participation in the Events whether in contract, tort (including negligence or breach of statutory duty) or otherwise.
- 3.2 The Participant hereby grants to the Organizers the right to photograph and/or videotape the Participant during his or her participation in the Events. The Participant further grants to the Organizers a world-wide, royalty-free and perpetual right to use the images and videos of the Participant's likeness, voice and sounds during his/her participation or published by the Participant to participate in the Events, and to license such right to reuse such images and videos of his/her participation, and his/her name, likeness and biography, in any and all media for any purpose, including advertising and other promotions, without compensation to the Participant or his/her parent or guardian. Each of such images and videos shall be a work for hire and the Organizers shall be deemed the owners of any copyright and/or trademark rights therein. The Organizers may use the Participant's information for their programme and promotions.
- 3.3 The Participant (and the Parent/Guardian of a Participant underage) agrees, confirms and undertakes with the Organizers as follows:-
 - (a) the Participant consents to the collection, use and disclosure of his/her personal data for the purposes of facilitating his/her participation in the Events;
 - (b) the Participant shall indemnify the Organizers for (i) any damage to property, loss, expense or cost suffered by the Organizers; and (ii) against any claim made by any third party against the Organizers and from any expense or cost incurred by the Organizers in the event they are held liable for damages in respect of such claim by reason of or arising out of any injury, death, damage to property, loss, expense or cost occurring to any person which is caused by or as a result of any act or omission of the Participant.
